Pricing & Orders

All prices are in Canadian dollars and are subject to change without notice. Confirmed purchase orders are binding. Cancellations must be requested in writing within 24 hours of order placement. PROKAHL is not liable for price differences arising from market fluctuations after an order has been confirmed.

Returns & Claims

Returns are accepted within 15 days of delivery for unopened, undamaged goods in original packaging. A restocking fee of up to 15% may apply. Defective or incorrect goods must be reported within 5 business days of receipt. No returns will be accepted without a Return Merchandise Authorization (RMA) number.

Delivery
